#### **CONTRACTOR REGISTRATION**

In compliance with Chapter 1452 of the Codified Ordinances of the City of Mentor-on-the-Lake, all contractors and subcontractors performing work within the City must register and obtain a license to do so.

The following information and fee are required for 2019 registration:

- 1. Completed application form
- 2. \$50.00 License Fee

\$5.00 Sign Permit (Optional) this would allow the business to display a sign on the property while working on the job, and up to ten days after completion

- 3. \$10,000.00 License Bond
- 4. Insurance certificate for coverage of \$1,000,000.00 liability and \$1,000,000.00 property damage
- 5. Pursuant to H.B. 434, the City requires a copy of your state license (If applicable)

The Ohio Construction Industry Licensing Board licenses commercial contractors for the following trades: electrical, HVAC, hydronics, plumbing, and refrigeration.

Details: General contractors performing electrical, HVAC, hydronics, plumbing, or refrigeration require a state license. All other construction contracting work is licensed by local jurisdictions. Check with your city and/or county government for specific licensing requirements.

# OHIO UNIVERSAL MARKING STANDARDS

# APWA COLORS

The American Public Works Association recommended color code shall be used to mark the location of underground facilities, temporary survey markings, and site of intended excavation. When utility company representatives mark a location, they use colored flags and/or paint to identify the type of underground service:

ORC 3781.29(C) | "A utility shall mark its underground facilities using the following color codes:..."

RED	Electric Power Lines, Cables, Conduit and Lighting Cables
YELLOW	Gas, Oil, Steam, Petroleum, or Gaseous Materials
ORANGE	Communication, Alarm or Signal Lines, Cables or Conduit
BLUE	Potable Water
PURPLE	Reclaimed Water, Irrigation and Slurry Lines
GREEN	Sewers and Drain Lines
PINK	Temporary Survey Markings
WHITE	Proposed Excavating
