Zoning Permit Process for Large Projects

- 1. Fill out the zoning permit application
- 2. Submit 2 copies of the certified site plan and 2 copies of the building plans
- 3. At this point of the application process, you will need to submit the following fees/deposits:
 - a. Review Fee \$25.00
 - b. Grade Plan Fee \$100 (Residential) \$200 (Commercial)
 - c. Engineer Deposit \$500.00

The site plan will be sent and reviewed by the engineer. Please allow up to 3 weeks for the approval of your site plan.

- 4. Once we receive your approved site plans, your zoning permit will be prepared and available. When you pick up your permit, you will need to bring the following fees/deposits:
 - a. Zoning Permit Fee (Please see the Zoning Permit Fee list)
 - b. Road Bond Fee (\$5 per lineal foot frontage)
- 5. Along with your Zoning Permit, you will also receive the Temporary Occupancy Certificate
- 6. You will also receive your approved site plan and your building plan.
 - a. Bring both the site plan and building plan to the Lake County Building Department

Once the job is complete:

- 7. You will need to submit the as built along with the Lake County Final Inspection Report
- The engineer and the zoning director verifies the completed job
- Once Lake County has completed their final inspection we can release the road bond and remaining engineer deposit
- When the project is complete, a permanent occupancy certificate will be issued

APWA COLORS

The American Public Works Association recommended color code shall be used to mark the location of underground facilities, temporary survey markings, and site of intended excavation. When utility company representatives mark a location, they use colored flags and/or paint to identify the type of underground service:

ORC 3781.29(C) | "A utility shall mark its underground facilities using the following color codes:..."

RED	Electric Power Lines, Cables, Conduit and Lighting Cables
YELLOW	Gas, Oil, Steam, Petroleum, or Gaseous Materials
ORANGE	Communication, Alarm or Signal Lines, Cables or Conduit
BLUE	Potable Water
PURPLE	Reclaimed Water, Irrigation and Slurry Lines
GREEN	Sewers and Drain Lines
PINK	Temporary Survey Markings
WHITE	Proposed Excavating
