

ORDINANCE NO. 2019-0-39

**AN ORDINANCE AMENDING CODIFIED ORDINANCES 1062.01 AND 1062.02
RELATING TO FEES FOR THE COMMUNITY ROOM**

WHEREAS, Council wishes to amend Ordinance 1062.01 in order to change the fees that are charged for the use of community room of the City.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Mentor-on-the-Lake, County of Lake and State of Ohio, as follows:

Section 1. That Codified Ordinance Section 1062.01 is amended and as amended Section 1062.01 hereby reads as follows:

Effective December 1, 2019 and until such time as Council deems it necessary to adjust the rate, the fee for use of the Community Room shall be as follows:

(a) by a resident or employee of the City or a nonprofit groups whose membership includes Mentor-on-the-Lake residents the sum of fifteen dollars (\$15.00) per hour or sixty dollars (\$60.00) for five hours for residents. If additional time is required there will be an additional fee of ten dollars (\$10.00) per hour for each additional hour over the five hours reserved

(b) by a non-resident of the City the sum of twenty-five dollars (\$25.00) per hour or one hundred dollars (\$100.00) for five hours. If additional time is required there will be an additional fee of twenty dollars (\$20.00) per hour for each hour over five hours.

(c) by a for-profit corporation or for non-profit corporations that are not a 501(c)(3) organization and that do not include a Mentor on the Lake residents as part of their membership the sum of twenty-five dollars (\$25.00) per hour or one hundred dollars (\$100.00) for five hours. If additional time is required there will be an additional fee of twenty dollars (\$20.00) per hour for each hour over five hours.

(d) by a 501(c)(3) non-profit corporations that does not include a member who is a City resident, the sum of twelve and 50/100 dollars (\$12.50) per hour or Fifty dollars (\$50.00) for five

hours. If additional time is required there will be an additional fee of ten dollars (\$10.00) per hour for each hour over five hours.

(e) All persons and/or entities that use the community room shall pay for the use of the community room according to the fee structure set forth above. No person and/or entity that uses the community room shall be allowed to use the community room free of charge.

Section 2. That Codified Ordinance Section 1062.02(b) and (c) are amended and as amended hereby reads as follows:

(b) When the Community Room has not been reserved by or is not required by the City, it may be used as a meeting area for established clubs, organizations and recognized nonprofit groups whose membership includes Mentor-on-the-Lake residents and also by non-residents and for profit corporations and not for profit corporations that do not include a Mentor on the Lake resident.


(c) The Community Room may be reserved for use by Mentor-on-the-Lake residents, City businesses and their employees and by non-residents and by for profit and nonprofit corporations for a nonrefundable fee on any day during which the Community Room is not reserved or required by the City for City related business.

Section 3. That all formal actions of this Council concerning the passage of this Ordinance were adopted in an open meeting, and that all deliberations of this Council, or any of its Committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREFORE, this Ordinance shall be in full force and effect thirty day after its passage by Council and approval by the Mayor.


