Resolution 2020-R-04

AN EMERGENCY RESOLUTION TO ACCEPT THE ONE OHIO MEMORANDUM OF UNDERSTANDING

AN EMERGENCY RESOLUTION AUTHORIZING the City Law Director to accept the One Ohio Memorandum of Understanding regarding the pursuit and use of potential opioid litigation settlement funds.

WHEREAS, the City of Mentor on the Lake Ohio (herein "Municipality") is a municipal entity formed and organized pursuant to the Constitution and laws of the State of Ohio; and

WHEREAS, the people of the State of Ohio and its communities have been harmed by misfeasance, nonfeasance and malfeasance committed by certain entities within the Opioid Pharmaceutical Supply Chain; and

WHEREAS, the State of Ohio, through its Attorney General, and certain Local Governments, through their elected representatives and counsel, are separately engaged in litigation seeking to hold Opioid Pharmaceutical Supply Chain Participants accountable for the damage caused by their misfeasance, nonfeasance and malfeasance; and

WHEREAS, the State of Ohio, through its Governor and Attorney General, and its Local Governments share a common desire to abate and alleviate the impacts of that misfeasance, nonfeasance and malfeasance throughout the State of Ohio; and

WHEREAS, the State and its Local Governments, subject to completing formal documents effectuating the Parties Agreements, have drafted a One Ohio Memorandum of Understanding ("MOU") relating to the allocation and the use of the proceeds of any potential settlements described; and

WHEREAS, the MOU has been collaboratively drafted to maintain all individual claims while allowing the State and Local Governments to cooperate in exploring all possible means of resolution; and

WHEREAS, nothing in the MOU binds any party to a specific outcome; and

WHEREAS, any resolution under the MOU will require acceptance by the State of Ohio and the Local Governments; and

WHEREAS, Council understands that the purpose of the MOU is to permit collaboration between the State of Ohio and Local Governments to explore and potentially effectuating earlier resolution of the Opioid Litigation against Opioid Pharmaceutical Supply Chain Participants; and

WHEREAS, Council understands that an additional purpose is to create an effective means of distributing any potential settlement funds obtained under the MOU between the State of Ohio and Local Governments in a manner and means that would promote an effective and meaningful use of the funds in abating the opioid epidemic throughout Ohio; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MENTOR ON THE LAKE, OHIO.

<u>Section 1.</u> That the City Law Director is authorized to accept the One Ohio Memorandum of Understanding on behalf of the City of Mentor on the Lake.

Section 2. That it is found and determined that all formal actions of the Council relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

Section 3. This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare and safety of the City of Mentor on the Lake. The reason for the emergency is to ensure prompt pursuit of funds to assist in abating the opioid epidemic throughout Ohio.

WHEREFORE, this Resolution shall be in full force and effect immediately upon
passage by Council and approval by the Mayor.

ORDINANCE NO: 2020 - O - 08

AN ORDINANCE AUTHORIZING ALL ACTIONS NECESSARY TO ACCEPT THE 2020 LAKE COUNTY ROAD IMPROVEMENT AND ECONOMIC DEVELOPMENT GRANT PROGRAM AND DECLARING AN EMERGENCY.

WHEREAS, on December 29, 2019 the Lake County Board of Commissioners adopted a resolution establishing the Lake County Board of Commissioners' Lake County Road Improvement and Economic Development Grant Program (2020); and

WHEREAS, the Lake County Board of Commissioners assert that quality roadway infrastructure is critical to economic development opportunities and providing a high standard of living for Lake County residents; and

WHEREAS, the Lake County Board of Commissioners committed \$1,500,000 in onetime grants to Lake County communities for any road improvement projects included in their Capital Improvement Plan; and

WHEREAS, using the 2018 Ohio Department of Public Safety Tax Distribution – Detailed Statement of Motor Vehicle Registrations, the total percentage of "Tot Reg" vehicles per community was calculated and multiplied by the \$1,500,000 funding budget to determine the grant distribution amount for each Lake County community; and

WHEREAS, the City of Mentor-on-the-Lake has identified roadways in need of improvement, and hereby creates the 2020 Concrete Slab Replacement Program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MENTOR ON THE LAKE, STATE OF OHIO, THAT:

Section 1: That the Council of the City of Mentor-on-the-Lake finds and determines that is in the best interest of the City of Mentor-on-the-Lake to accept the 2020 Lake County Road Improvement and Economic Development Grant in the amount of Forty-four thousand, nine hundred and fifty-three dollars and seventy-three cents (\$44,953.73).

Section 2: The actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings held in compliance with all legal requirements.

Section 3: This Ordinance is declared to be an emergency measure, necessary for the immediate preservation of the public peace, health and welfare of the residents of the City and for the further reason that the safeguards provided for in the Policy should be placed in effect as

soon as possible; wherefore, this Ordinance shall take effect and be in full force immediately upon its passage and approval by the Mayor.

THEREFORE, this Ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
