ZONING PERMIT PROCESS FOR LARGE PROJECTS

Step 1

SUBMIT THE FOLLOWING:

Zoning Permit Application, filled out in its entirety

 Certified Site Plans

with Grade & Building Plans (2 copies of each)

Check/Cash for the following fees/deposit:

Residential Project = \$625.00 Commercial Project = \$1,225.00

\$25.00 Review Fee \$25.00 Review Fee

\$100.00 Grade Plan Fee \$200.00 Grade Plan Fee

\$500.00 Engineer Deposit \$1,000.00 Engineer Deposit

*** Please allow up to 3 weeks for the return of your site plans *** Your plans are being reviewed by the City Engineer

Step 2

- You will receive a call that your site plans are approved and your zoning permit is prepared
- You may now pick up your approved site plans and zoning permit. You will need to bring check/cash for the Zoning Permit Fee and Road Bond Deposit:

Zoning Permit Fee

- Addition \$50.00 (Less than 600 sq. ft.)
 \$100.00 (600 sq. ft. or Greater)
- Change of Grade No additional fees are needed unless the actual Engineer cost exceeds the original deposit amount.
- Garage \$50.00
- New House/New Building \$100.00 (Residential)
 \$0.05 per front foot (Commercial) Minimum Amount of
 \$100.00

Road Bond Deposit

- Addition \$5.00 per front foot
- Garage \$5.00 per front foot
- New House/New Building \$12.50 per front foot (Residential & Commercial)
- Bring your approved site plans and building plans to the Lake County Building Department

Step 3

YOUR PROJECT IS COMPLETE:

- Submit the as-built for final zoning approval
- The City Engineer and Zoning Inspector will review the as-built plans to verify the completed project

Step 4

- You will receive a call that your as-built plans are approved and available for pickup
- Take the approved as-built to Lake County Building Department for final inspection

Step 5

- Once Lake County Building Department submits it's approved final inspection, your Road Bond and remaining Engineer Deposit funds will be released
- A permanent Occupancy Certificate will be issued by Lake County.
