A RESOLUTION AUTHORIZING THE ROAR BY THE SHORE COMMITTEE TO USE THE CITY HALL PARKING LOT AND ADJACENT LAND FOR THE ROAR BY THE SHORE EVENT IN 2024, 2025 AND 2025

WHEREAS, for over ten years a car show has been held in the City of Mentor on the Lake by the Roar by the Shore Committee and this car show has had widespread acceptance in the Mentor on the Lake Community and beyond; and

WHEREAS, last year the City hosted the Roar by the Shore car show because the Roar by the Shore Committee was not able to find any other location in the City to hold this car show and once again the car show at the City location turned out to be successful and well received by the public and it also turned out to be a benefit to the Mentor on the Lake residents and the public; and

WHEREAS, the stated purpose of the Roar by the Shore Committee is charitable in nature and any money raised by this event is donated to a Veterans organization and/or a Veterans related non-profit organization; and

WHEREAS, the Administration and Council wish to allow this event to once again occur at the City Hall Parking lot and adjacent land on the Saturday of Labor Day Weekend in 2024, 2025 and 2026; and

WHEREAS, this is not a City event and the purpose of this Resolution is to establish clear authority that will permit the Mayor to allow the usage of City lands for this event.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MENTOR ON THE LAKE, COUNTY OF LAKE, STATE OF OHIO:

SECTION 1. That the Mayor is authorized to allow the Roar by the Shore Committee to use the City Hall Parking lot and adjacent land on the Saturday of Labor Day Weekend in 2024, 2025 and 2026. The Mayor and the Administration are further authorized to designate the areas where the car show can occur, the amount of liability insurance that will be required to be posted by the Roar by the Shore Committee and such other rules and regulations as deemed necessary by the Mayor and the Administration in order to protect the public and to protect the City parking lot and lands. Such rules and regulations may include but are not limited to the date the event will occur, the time period for the event, clean up rules and requirements for security which may include the payment for off-duty and/or on duty Mentor on the Lake police officers. The Roar by the Shore Committee shall also comply with all of the requirements of Chapter 864 - Special Events for this car show.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that, except as otherwise provided by Section 121.22 of the Ohio Revised Code, all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

WHEREFORE, this Resolution shall be in full force and effect as provided by law.
