

ORDINANCE NO. 2024-O-17

AN ORDINANCE TO APPROVE THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES; TO PROVIDE FOR THE ADOPTION OF NEW MATTER IN THE UPDATED AND REVISED CODIFIED ORDINANCES; REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH; AND DECLARING AN EMERGENCY.

WHEREAS, American Legal Publishing Corporation has completed its annual updating and revision of the Codified Ordinances of the City; and

WHEREAS, various ordinances of a general and permanent nature that have been passed by Council since the date of the last updating and revision of the Codified Ordinances (December 31, 2022) have been included in the Codified Ordinances of the City; and

WHEREAS, certain changes were made in the Codified Ordinances to bring City law into conformity with State law;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mentor-on-the-Lake, Ohio:

SECTION 1. The editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of the City, so as to conform to the classification and numbering system of the Codified Ordinances:

SECTION 2. The following sections in the Codified Ordinances are or contain new matter and are hereby approved, adopted and enacted:

402.077, 402.37, 408.02, 432.30, 432.43, 434.03, 436.09, 438.16, 438.17, 438.28, 440.01, 442.01, 442.03, 442.05, 452.04, 606.01, 606.29, 612.07, 624.01, 624.03, 624.20, 636.19, 648.07, 648.14, 666.07, 672.16, 672.17, 698.02

SECTION 3. All ordinances and resolutions and parts thereof that are in conflict with any of the provisions of the new matter approved, adopted and enacted by Section 2 hereof are hereby repealed, except as follows:

- (a) The enactment of such new matter shall not be construed to affect a right or liability accrued or incurred under any legislative provision prior to the effective date of such enactment, or an action or proceeding for the

such legislative provision or to affect an indictment or prosecution therefor. For such purposes, any such legislative provision shall continue in full force notwithstanding its repeal for the purposes of revision and recodification.

- (b) The repeal provided above shall not affect any legislation enacted subsequent to December 31, 2023.


SECTION 4. Pursuant to R.C. § 731.23 and 731.25(A) and Section 212.01 of the Codified Ordinances, the Clerk of Council shall cause a notice of the enactment of this ordinance, containing the title of this ordinance and a summary of the new matters covered by it, which summary is attached hereto as Exhibit A, to be posted for not less than fifteen days after passage in the five public places provided in Section 212.01.

SECTION 5. All formal actions of this Council concerning the passage of this ordinance were adopted in an open meeting, and all deliberations of this Council, or any of its committees, which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including R.C. § 121.22.

SECTION 6. This ordinance is hereby declared to be and is passed as an emergency measure, the emergency being the need to have an up-to-date code of laws with which to govern and administer the affairs of the City. Such ordinance is necessary for the immediate preservation of the public peace, health, safety and welfare of the City and shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
