Phone: Monday-Saturday 9:00 a.m. to 9:00 p.m.

\*Solicitation will not be permitted on state or federally observed holidays\*

#### **Process:**

#### 1. Solicitation Application

(Each person must submit an application with the following information)

- \$30 Non-refundable Fee
- 2 Photos of the Applicant (2" X 2")
- CCA Municipal Income Tax Form (<u>only 1 per group</u>) Note: CCA form not needed for 1 week permits
- Finger Prints: BCI & FBI
   (visit website below for list of locations)
   www.OhioAttorneyGeneral.gov/WebCheck
- 2. Part 2 must be completed by the MOL Police Department
  - Background check
  - Vehicle Inspection (if necessary)
- 3. City Hall will contact applicant. If application is approved applicant must come to City Hall to obtain Solicitor's Permit. Prices are listed above.
- 4. Upon approval, applicant will be given a current **NOPEC BlockTheKnock** program list of Mentor-on-the-Lake addresses that have requested their home not be approached by solicitors.

\*Though there may be just one employer, each individual <u>MUST</u> have their own permit\*
