January 25, 2024

Since this Board last met on October 26, 2023, there is significant Council activity on which to report:

2023 General Election, Appointments, and Changes

- Mayor Eva has been re-elected
- Ward 1 is now represented by Jeannie Wong; Ward 2 is now represented by Skip Gray
- Ward 3 re-elected Rob Johnson, subsequently re-elected as Council President; Ward 4 re-elected Desirea
 Thompson, subsequently elected as Council Vice-President
- Three At-Large Councilors are completing their terms
- Thank you to Dave Chabut (Council Ward 1) and Paul Morris (Council Ward 2) for their service.
- Thanks also to Joyce Saxe, Clerk of Council, who retired in December. Welcome to Taylor Conner, our incoming Clerk of Court. Her contact email address remains councilclerk@citymol.org
- New appointments to Council Committees and Boards are reflected on our City Web site
- Ballot Levies: All 4 tax measures on the Ballot passed. This includes Issues 6, 7, 8 Renewal levies for Police, Fire, and Roads; Issue 5 New tax levy for the benefit of Parks & Recreation

Comprehensive Municipal Plan

- A Request for Proposals (RFP) for creation of a Comprehensive Municipal Plan was approved by Council and sent out by the Mayor. This plan would aid long term planning and vision goals, as well as improve our City's candidacy for grants of local, county, state, and federal money to fund projects, which could include public Park and infrastructure improvements. The deadline for bids to be received by the City is March 1.

Update on the Crane's Landing project:

- The updated Preliminary Development Agreement, building plans & renderings, and related documents from the Sommers Group were approved by P&Z Commission on Jan 8, 2024, and returned to Council for review. A Public Hearing is scheduled for Tues, Feb 13, 2024 to vote on application of the Planned Use Development for these parcels to allow for a non-Business or Single-Family District use, for which the land is currently zoned.
