

RESOLUTION NO. 2025-R-18

A RESOLUTION AUTHORIZING THE MAYOR AND ADMINISTRATIVE DIRECTOR TO ENTER INTO AN AGREEMENT WITH TIM LALLY CHEVROLET TO PURCHASE A 2024 CHEVY SILVERADO 1500 4X4 POLICE TRUCK AT STATE-TERM CONTRACT PRICING, AT A PRICE NOT EXCEED \$62,000.00,-AND DECLARING AN EMERGENCY.

WHEREAS, Section 227.01(d) of the City's Codified Ordinances provides that all purchases over \$50,000, other than professional services contracts, must be competitively bid; and

WHEREAS, Section 222.05 of the City's Codified Ordinances provides an exception to the City's requirement for competitive bidding for the purchase of goods and services through the City's participation in pricing procured by the State of Ohio Department of Administrative Services ("State Term Contract"); and

WHEREAS, the Administrative Director desires to place an order with Tim Lally Chevrolet, at State Term Contract pricing, for a 2024 Chevy Silverado 1500 4x4 Police Truck, including all police required upgrades, in an amount not to exceed \$62,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the City to authorize the Mayor and Administrative Director to enter into an agreement to purchase a 2024 Chevy Silverado 1500 4x4 Police Truck, including all police requirement upgrades, in an amount not to exceed \$62,000.00, pursuant to State-Term Contract pricing.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MENTOR-ON-THE-LAKE, COUNTY OF LAKE, AND STATE OF OHIO, AS FOLLOWS:

Section 1. The Mayor and Administrative Director are authorized to enter into an agreement to purchase a 2024 Chevy Silverado 1500 4x4 Police Truck, including all police requirement upgrades, from Tim Lally Chevrolet, in an amount not to exceed \$62,000.00, pursuant to State-Term Contract pricing.

Section 2. The Mayor and all other City officials are authorized and directed to sign and/or enter into any instruments of conveyance or other documents necessary to effectuate the provisions of this Resolution. Additionally, the Mayor and City Administrator are authorized to enter into any purchase orders of less than the amount required by Section 227.01(a) of the City's Codified Ordinances that are necessary to equip the 2024 Chevy Silverado 1500 4x4 Police Truck.

Section 3. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting and that all deliberations of this Council, or any of its Committees which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22, of the Ohio Revised Code.

Section 4. That this Resolution is hereby declared to be an emergency measure, and is passed as such; the emergency being the need to immediately purchase the 2024 Chevy Silverado 1500 4x4 Police Truck so that the City may maintain a satisfactory fleet of police vehicles, in particular during the ongoing supply chain issues surrounding the same. Said Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the City.

WHEREFORE, this Resolution shall be in full force immediately upon its passage by Council and approval by the Mayor.


