The regular meeting of the Board of Zoning Appeals for the City of Mentor on the Lake, Ohio was called to order by Ms. Hathaway on January 17, 2022 at 6:00 p.m. in the Community Room of City Hall, 5860 Andrews Road.

NEW BUSINESS: Continue to review the setback variances for a new build at 5446 Coronada Drive for George & Kerry Pelesky. The setbacks did not meet the requirements of ordinance 1252.04.

At the last meeting this variance request was tabled. It was asked that the Law Director review and submit his recommendation for the Board to review for a final determination.

Law Director, Jim Lyons, submitted his recommendation by email. Mr. Lyons suggested that Mr. Pelesky submit two more drawings. One drawing that shows the layout as proposed by Service Director, Hollie Bartone. Her request was to have the location of the home shift to the south 7.5' and the west 3'. The other drawing is to show the layout that the Board had proposed. The Board proposed rotating the placement of the home as to maintain the allowable 20% variances. Mr. Lyons also asked that Mr. Pelesky provide information to show that the building, including accessory structures, do not cover more than 30% of the area of the parcel.

Mr. Pelesky provided the Board with everything that had been asked of him. He submitted by email to Ms. Hathaway and verified that the structures do not exceed the 30% rule. "As for the 30 percent rule, we are at 23 percent including driveway. This has been noted on the original submission."

The Board reviewed the drawings. Since both drawings conformed to the allowable 20% variance that the Board can approve they asked Mr. & Ms. Pelesky what layout would best suit them. Mr. & Ms. Pelesky agreed that the rotation of the home, suggested by the board, would best suit their interest as it allows for them to have a better view of the Lake. This rotation shifts the home to align parallel with Granada Drive.
