MINUTES VIRTUAL REGULAR MEETING OF COUNCIL CITY OF MENTOR-ON-THE-LAKE FEBRUARY 23, 2021

The Virtual Regular Meeting of Council of February 23, 2021, for the City of Mentor-on-the-Lake, Ohio, was called to Order at 7:00 P.M. by Council President Desirea Thompson.

Mrs. Thompson asked if Mr. Lyons wanted to comment on this. Mr. Lyons said it was brought to his attention by an email from one of the Council Members that, in reviewing the Minutes from the Organizational Meeting, it appeared there was no vote conducted after the closing of nominations. He replied he would check it out at the Agenda Meeting. The Clerk actually listened to the tape of the meeting, and he reviewed the Minutes, and there was no vote. He reviewed Roberts Rules of Order and there was nothing that specifically dealt with this, but it did talk about if there was unfinished business, it had to be finished and carries over to the next meeting. This has carried over to the fourth meeting, but it still has to go to a vote. It turns out that under our Rules the Senior Member of Council is the person who presides at the meeting and that happens to be Mrs. Thompson, who was the Past President and who was nominated again. We do need to take a vote on this to have it officially on the record.

Mr. Bittner advised he had received an email from Tom Olsen regarding the snow at the Giant Eagle parking lot and the way it is being plowed. He talked to the Fire Chief and Service Director. It is private property so there is not a lot that can be done. Per the Fire Chief, there is not a fire hazard, everything is still accessible. You might have to drive around a little bit more and it is a little more inconvenient, but it is all within Code. Mr. Bittner emailed Mr. Olsen and he was happy with that. Mr. Olsen personally had reached out to the store.

Mrs. Thompson asked for a Motion to amend tonight's Agenda to add the Expenditure Approval from Mrs. Bartone.

ADMINISTRATIVE AND DEPARTMENT HEAD REPORTS:

Mayor & Safety Director - Mr. Eva

Mayor Eva stated Jamie McCullough started on February 15, 2021, as City Hall Administrative Assistant and Secretary. Jamie was with us last year assisting in the Police Department. Tony Osap started as a Part-Time Police Officer and started his field training on February 17, 2021, with Sgt. Daubenmire.

Mayor Eva read a couple of Memos from Chief Pechatsko regarding the structure fire on February 14, 2021. The structure fire was early in the morning of February 14th on Southland. We had all of the Departments, Fire, Police, and Service Departments, working together. In the Memo to Chief Gielink, Chief Pechatsko commended several members of the Police Department for their actions during the fire. Communication's Officer Nosse did an excellent job in dispatching the Fire Department and Auto Aid Departments very quickly, and handled the radio traffic in a professional manner. Ptl. Mattson helped by taking some video and pictures of the fire, and took care of the occupants of the house, allowing the Fire Department to concentrate on fighting the fire. Sgt. Daubenmire anticipated icing conditions due to the cold temperatures and called the Service Department to bring down road salt, and then assisted with spreading the sale to provide a safer condition for the Fire Department to work in. In a Memo to Brent Moore, Service Director, Chief Pechatsko thanked the Service Department for its assistance during the structure fire, and thanked Foreman Turoski who came down in a salt truck and spread salt by hand to provide a safer working environment. He also spread salt on the adjacent street to prevent icing.

Mayor Eva stated, along those same lines, he received an email from Ray Gieling, who is on the Board of Zoning Appeals, on February 15, 2021. Mr. Gieling wanted to share an idea regarding families affected by fire in the City, and wondered if there is a program for residential residents affected by fire damage. Mr. Gieling shared an idea about the City providing lodging for one night at the Holiday Inn on Route 306. The Holiday Inn gives discounted rates for situations such as fire, and he feels that one night is

something the community can do since the family has lost their home. After one night, the family can collect their thoughts and handle their affairs. Mr. Gieling is willing to spearhead this project with Mayor Eva. Mayor Eva wanted to share this with Council and would like to discuss this at the proper time.

Mayor Eva advised there is a position available on the Planning and Zoning Commission. This opening will fill the term ending December 31, 2023. Applicants must be residents and registered voters for at least two years. He advised Mr. Sheldon has accepted a position out of town and will here for at least the next two Planning and Zoning meetings but is looking to relocate sometime in May.

Mayor Eva received a nice card from Lynn Hawkins, John Hawkins' wife. Mayor Eva had a Proclamation prepared, and she thanked him for this.

Mayor Eva said he had a Memo from both Chief Gielink and Chief Pechatsko to Michelle Patete, who is a resident at Andrews Place Apartments, thanking her for her generous donation of Subway gift cards.

Administrative Director - Mrs. Bartone

Mrs. Bartone stated there was a discussion on the CRA Ordinance a couple of meetings ago and Mr. Lyons had asked her to find out why it was not codified. She did hear back from American Legal. Generally CRA's that create specific areas are not codified. The person who was updating our records that year thought it was a specific area and not the entire City so they will work on adding that with this year's updates.

Mrs. Bartone stated, as everyone is aware, Mr. Morris has been sending her questions relating to the budget and the Fire Department. As an update on the numbers he requested, she has Elaine working on writing a program within their software to extract the information requested which is taking some time as they are in the middle of the audit and software upgrade.

Relating to the Expenditure Request on the Agenda, this is already in the budget and is for the Police Department's annual purchase of a vehicle.

Law Director - Mr. Lyons (No Report)

Service Director - Mr. Moore

Mrs. Bartone read Mr. Moore's report. The 2020-2021 winter season has been mild, salting and plowing of roadways continues when needed. The Service Department has been patching potholes as the weather permits and working on straightening and replacing signs as needed. If anyone has any complaints, please forward them to Mr. Moore so he can address them. During 2020, 457 OUPS utility protection tickets were investigated and reported. The Housing Department conducted 145 point of sale inspections, 25 rental inspections, and 73 inspects. They continually do maintenance on all the police cars and Service Department vehicles. In March they will begin preparing for summer operations.

QUESTIONS TO ADMINISTRATION AND DEPARTMENT HEADS:

Mr. Chabut asked Chief Pechatsko, in discussing making part-timers non-classified, the Ordinance Committee wanted to know specifically about the cost differences and effect on service if the Part-Timers become non-classified. Chief Pechatsko stated the cost would be minimal as far as the City would save a little bit of money just by not having to give part-timer tests in order to employ part-time personnel. This would not change service whatsoever. Mr. Chabut thanked Chief Pechatsko and asked if anyone else had any questions. Mr. Morris asked Chief Pechatsko who would become the officers in charge of the shifts if there are not part-time officers. Chief Pechatsko said there is currently four part-time officers and also

full-time who are now there 24/7, around the clock. Mr. Morris asked Chief Pechatsko what was he telling him, who would be in charge of the shift. Chief Pechatsko said when an officer is there, the officer is in charge of the shift, and in lieu of an officer, the full-time member is in charge of the shift. Mr. Morris asked if the City chooses to remove the part-timers from the Civil Service Rules, how do you promote an officer. Chief Pechatsko said the full-time member would be in charge of the shift. There are currently four officers and he does not believe they are going anywhere any time soon. Mr. Morris asked, when they do, and the part-timers are removed from Civil Service, which is the method through which they are promoted through a Civil Service exam, when these gentlemen leave the job, Chief Pechatsko was still not answering his question. Chief Pechatsko said he thought he had answered it; the full-time members would be in charge of the shift. Mr. Morris asked, when these part-time officers leave, instead of making new part-time officers to fill their positions, the full-timers become the officers. Chief Pechatsko said no, the full-timers would be in charge of that shift, it would not necessarily create an officer position in the full-time ranks. Mr. Morris said, so then you would operate the shifts without officers. Chief Pechatsko said that was correct. Mr. Morris said, I see.

BOARD/COMMITTEE/COMMISSION REPORTS:

Ordinance Committee / February 15, 2021 / Mr. Chabut

Mr. Chabut stated the Ordinance Committee met on February 15, 2021, at 6:05 P.M. Present were Council Members Chabut, Johnson, Wolk, Morris, and Vice-President Lunder. The Committee went over about six Ordinances. Ordinance 1242.10 regarding fireplaces and inspection fees was approved to send to Council for tonight's Agenda. Ordinance 1036 regarding trees, the Committee agreed to forward this to the Planning and Zoning Commission for their input. Ordinance 1466 was sent to Mr. Lyons for further changes. The Committee discussed that extended vacationers were exempt for eight months, and that the property should be actively on the market for the exemption. Ordinance 1024.01 regarding culverts, the Committee discussed whether the City should do culvert repairs and it was decided by the Service Director and City Administrator not to change this Ordinance. Ordinance 2020-O-23, concerning the Fire Department, the Committee decided to have the Fire Chief come to the next Council Meeting on February 23, 2021, so the Committee could ask more questions about the cost differences and effect on service if the part-timers become non-classified. Ordinance 2020-O-28, regarding the CRA, the Committee agreed to forward this to Mr. Lyons to clarify wording as to property owners and builders. The Committee discussed at the next meeting discussing a possible ordinance for vacant property and its maintenance by the property owners. The next meeting will be held on March 15, 2021, at 6:00 P.M. The meeting adjourned at 7:05 P.M.

There was no Motion for Suspension of the Rules. Ordinance No. 2021-0-07 is placed on Second Reading.

OLD BUSINESS:

Mr. Morris asked if Chief Pechatsko was still here, and stated he was still perplexed by his ideas of running the Fire Department with the amount of people he has with the chief officer and one full-time lieutenant, that is what his plan is, correct. Chief Pechatsko stated, again, they currently have part-time officers, a full-time Lieutenant, and himself. They also have three more than capable full-time career firefighters in the Department that can run a shift. Mr. Morris asked if he felt comfortable with them commanding the scene at a structure fire. Chief Pechatsko said he did. Mr. Morris said he had more faith in them than he (Mr. Morris) did. They are great guys; their command experience or education, he thinks it is a mistake. Mrs. Bartone added, right now, say if one of the lieutenants resigned and they hired a part-timer into that rank, that part-timer only has to be here for six or twelve months before they can qualify for that position. You can have a part-timer that has twelve months on the job running a fire scene if he is the only ranking officer, potentially, at the scene. Mr. Morris said potentially, that is correct, but to become an officer you have to pass a promotional exam and have knowledge of that position. These people he is talking about have not done so. Chief Pechatsko said he begged to differ with him, in fact, both Jeremy Campaign and Gabe Ananea did pass the full-time lieutenant's test when it was given, it just happened that Lt. Konte scored higher and was promoted into that position. Mr. Morris said he is still opposed to this plan. He thinks it is a serious mistake; and Chief Pechatsko's comment at one time about trying to match the Police Department; or to have our department mirror other departments in the County, there is no other department in this County that operates this way, is there? Chief Pechatsko said, again, we still have part-time lieutenants and a full-time lieutenant, so it is not like we are completely eliminating an officer position in the Department. Mr. Morris said he is talking now, sir, about the future. If the part-time people are taken out of Civil Service, he has to assume there will be no more part-time officers after this point when these people retire. Chief Pechatsko said that was correct. Mr. Morris, again, said he thinks this is a serious mistake. Mrs. Bartone asked Mr. Morris if he had any suggestions. Mr. Morris said keep the part-time officers in place. It is cheaper than hiring fulltimers to run the shifts because eventually he imagines they will want a stipend to become the shift officer. Mrs. Bartone asked like the part-timers did; Mr. Morris said yes, like the part-timers did. He is opposed to this, and to his companions on Council, Mr. Lunder and Mr. Bittner who served on that Department, if they agree with this, he is shocked. Mr. Lunder said he did not have a problem with it; what he has a problem with is what Mr. Morris is trying to do to Chief Pechatsko here. You have four full-time firemen over there; it is their responsibility for that shift. They are well capable of running a shift, and if there is a fire like we had on Sunday, it is going to go out for mutual aid anyhow and Chief Pechatsko will be there in charge anyhow. Mr. Morris said no, you can't guarantee that, and Mr. Lunder knows that from his time on the Department. Mrs. Bartone said, continuing on Mr. Morris' comment. back when he was here as a full-time fireman, would he have been comfortable with a part-timer who had tested in that position having served twelve months as a firefighter, would he have been comfortable serving under that fireman at a scene. Mr. Morris said if he earned the rank of lieutenant or above, ves he would. Mr. Bartone said because he tested into it after twelve months, had no experience other than twelve months, Mr. Morris would be comfortable with that. Mr. Morris said yes, it's happened. He is sure the part-time lieutenants right now have never commanded a scene at a structure fire. Mrs. Bartone said right, and the four part-time lieutenants are not even medics. Mr. Morris asked what lieutenants. Mayor Eva said the part-time lieutenants. Mr. Morris asked if there were four part-time lieutenants. Mrs. Bartone said yes, two battalion chiefs, four part-time lieutenants. Mr. Morris

asked who the part-time lieutenants are. Mrs. Bartone started to name them, starting with Cassidy. Mr. Morris said Cassidy has not been on this Department in a year or better. Mrs. Bartone said he is still rostered. Mr. Morris said come on now. Mrs. Bartone said he has not resigned. Mr. Morris said he has. Mrs. Bartone said he has not. Mr. Morris said according to him, he has. Mrs. Bartone said she has not received a letter of resignation. Mayor Eva said there is no resignation letter. Mr. Morris asked if they thought a letter was needed to resign. Mrs. Bartone said the auditors would like her to have a letter saying he resigned. Mr. Morris said he talked to him about six months ago and he has resigned, you are not going to get a letter. Chief Pechatsko asked who they were speaking about. Mrs. Bartone said the first person she mentioned was Lt. Cassidy. To her knowledge she has not been informed on the HR side that he has officially resigned. Mr. Morris asked when was the last shift he pulled. Mrs. Bartone said that was not up to her. Mr. Morris asked Chief Pechatsko when was the last shift Lt. Cassidy responded to. Chief Pechatsko said he would have to research that and get back to Mr. Morris. His locker is full, and he has not turned in a resignation letter yet. Mr. Morris asked if he had turned in his radio and gear. Chief Pechatsko said no. Mr. Morris asked if Cassidy still had his radio. Chief Pechatsko said he was never assigned a radio. Mr. Morris asked if he was ever given a pager. Chief Pechatsko said he still has his pager. Mr. Morris said that is contrary to what Cassidy said to him. Mayor Eva said we are not getting anywhere with this, enough, ok. Mr. Morris said it is not ok, he thinks there is an ulterior motive going on in the Fire Department that is not being portrayed correctly. He hears tap dancing going on all the time. Mayor Eva said there is no tap dancing; Chief Pechatsko has been very clear about what he is trying to do, and Mayor Eva is behind him 100%. Mr. Morris said he is glad he is.
