READING OF MINUTES:

Regular Meeting of Council – March 28, 2023

The Clerk read an email from Anita Beard regarding collection problems with Republic Services, and the response from Mike Fedor with Republic Services. Copies of these emails are attached.

ADMINISTRATIVE AND DEPARTMENT HEAD REPORTS:

Mayor and Safety Director - Mr. Eva

Mayor Eva presented Proclamations to Daniel Coughlin and Anthony Konte in recognition and thanking them for their distinguished years of service on the Mentor-on-the-Lake Fire Department.

Mayor Eva swore in Joshua Sundbom and Daniel Klems as full-time Firefighters for the City of Mentoron-the-Lake Fire Department.

Mayor Eva read a letter from NOPEC advising City residents will be receiving natural gas and electric enrollment letters which they are required to send by the PUCO. Customers do not need to take any action as they will be automatically enrolled beginning with the June 2023 meter read date.

The Fire Department Report for March 2023 was read by Mayor Eva. During the month of March 2023, there were a total of 129 calls for service as follows: Fire//Rescue – 22 calls; Rescue/EMS – 107 calls, of which there were 22 calls for invalid assist, 1 call for an overdose requiring the use of Narcan. The Year

to Date Report for the First Quarter of 2023 is as follows. For the First Quarter of 2023 there were a total of 366 calls for service as follows: Fire/Service – 50 calls; Rescue/EMS – 316 calls, of which there were 56 calls for invalid assist and 3 calls for an overdose requiring the use of Narcan.

Mayor Eva advised Mr. Lyons had sent out letters to the parking lot owners by Marco's giving them until March 31, 2023, to respond. Guggenheim Real Estate Group responded they will have paving completed by May 31, 2023, and are looking to potentially having it done sometime in the beginning of May.

Administrative Director - Mr. Ness

Mr. Ness advised he is almost finished with the audit. A&J Cement plans to start repairing concrete between Goldenrod and Larkspur starting next week, and doing the same for asphalt between Beech Drive and Thunderbird and Fern Drive by the end of this month. Mr. Ness advised Morton Salt is trying to figure out what they are going to do since everybody did not use enough salt this year for their contracts. 71 Tons is our minimum threshold, and if we got what we ordered, 135 tons, would be what it actually needed. The Administration is waiting to see if Morton Salt is going to let it slide, or if we are going to have to store it, or figure something else out.

Law Director: Mr. Lyons

Mr. Lyons commented as he was sitting here watching the firemen, he thought it was a very, very impressive group of people, and how lucky we have been to have them helping our Community. He thought what a great service the two Lieutenants did from 1989 to 2023, and just how lucky we were.

Mr. Chabut stated the Planning and Zoning Commission met on April 3, 2023, at 6:00 P.M. Present were Commission Members Mike Sweeney, Brent Moore, and Al Buescher, Council Members Chabut Lunder, Vice-President of Council Moore and Council President Johnson, Mayor Eva, and some residents. There were three Conditional Use Permits on the Agenda,. The Conditional Use Permit for Mentor Harbor Yacht Club was approved after a lengthy discussion; Conditional Use Permits for Pelican's SnoBalls and Wing Stop were approved. The ARTARP Ordinance, 2022-O-24, was tabled until the next Meeting because the Committee did not receive the latest copy of the Ordinance. The next Meeting is scheduled for May 1, 2023, at 6:00 P.M. The Meeting adjourned at 7:05 P.M. Mr. Johnson asked if Mr. Chabut made sure they had the correct copy of the Ordinance for the next Meeting, and Mr. Chabut advised he had given it to them.

Mr. Johnson said he will assign this to the Zoning Committee. Mr. Bittner said the Ordinance Committee will look into it as well.
