Council Representative:

David Chabut reported that council is working on making the Fire Department Ordinance match the Police Department. A resolution designating April 2021 as Child Abuse Prevention Month was passed. Work continues on CRA to clear up language, flood damage and problems with vacant properties.

Mayor:

Mayor Eva reports that Al Buescher has moved from the Board of Zoning Appeals to the Planning and Zoning Commission to replace Adam Sheldon. The Board of Zoning Appeals is looking for a replacement for the term ending December 31, 2022. Cathy Roos inquired about the qualifications for the Board of Zoning Appeals. Mayor Eva explained the Board of Zoning Appeals position.

Mark Garland resigned as the Community Liaison from the Lake Health District Board after 18 years. Clerk will post a position opening, term ending in July of 2025. Position pays \$85 per meeting, 12 meetings per year, meetings are Mondays at 3:00pm, you are encouraged to get involved with other committees.

Mayor Eva met with Department Heads to review the budget requests and City Council approved the 2021 budget.

Chief Gielink and Mayor Eva met with AmVets regarding the Sunday, May 30th, Memorial Day Parade. Parade will start at City Hall at 1:00pm and will end at the AmVets Post.

Marcos Pizza still had no power at 4:00pm, they lost about \$3,000 in business (Marcos does a lot of fund raising for schools). Wendy Zeeley, our First Energy Representative is working with us to put together a plan to be proactive not reactive. First Energy is working on something on Lakeshore, we are concerned with Andrews Road. When the plan is received the Mayor will share with us.

Cathy Roos inquired about the Charter Review. Mayor Eva explained the next Charter Review is due in 2024.

Chairperson:

Michelle Moore reported that Brent Moore was retiring October 31, 2021.

Pavilion is almost ready to go, playground is being assembled, parks are being readied for summer. No beach access.

Michelle Moore stated that once the contest is public there is no way to screen where the votes are coming from. Mayor Eva said the contest didn't turn out the way the committee expected. Non-residents voted. Carol Stafinski wanted to know how we notified residents that their house was in the contest. Cathy Roos responded that the resident must register to be in the contest. Samantha Wolfe suggested a form with a google link. Mayor Eva said all participants were equal in the voting and then some houses had a surge of votes. Looking to make the contest voting just city wide. Desirea Thompson said we need to verify addresses. Participants must be registered with City Hall by December 10th. Voting will be the 14th-17th. Gift card prizes will be awarded on December 20th.
